USE RESTRICTIONS

This product may be used to repel Eastern moles (*Scalopus aquaticus*) from Lawns, Ornamentals and Turf.

LOCATING MOLES

The presence of moles may be indicated by a network of surface ridges in the turf or by a series of conical mounds of earth pushed up from deep burrows. Treat all areas that show signs of Moles' presence.

APPLICATION DIRECTIONS

SHAKE CONTAINER WELL BEFORE USING PRODUCT. Attach garden hose tightly to self-dispensing container. Turn water supply on to full pressure. Spray **ferti·lome® MOLEGO MOLE REPELLENT** over Mole infested area at a rate of one quart of product per 10,000 sq. ft. (e.g., a 100 ft. by 100

ft. rectangle). Adjust the spray nozzle to "WATER." Continue to spray water to soak **ferti·lome® MOLEGO MOLE REPELLENT** into the soil. Apply **ferti·lome® MOLEGO MOLE REPELLENT** immediately after the presence of Moles is detected or in early Spring, mid-Summer and early Fall if there are moles nearby but not on your property.
