**Common Sense Precautions**

- Keep out of reach of children. Wash hands well after use and before eating or smoking. Keep away from eyes and avoid directly breathing spray mist. After applying the product, it is recommended that you wait until the spray is dry before allowing children or pets back into the treated area. The product has the fresh scent of plant oils, which will dissipate over time. It is not usually objectionable when applied outdoors, but if necessary the product can be cleaned off of treated surfaces with water and dish soap to remove scent. If more than an incidental amount is swallowed, seek medical attention. Give one glass of water and do not induce vomiting. If in eyes, remove contacts and flush with water for 15 minutes. Seek medical attention for any persistent irritation. If seeking medical treatment, have this label with you.
- Do not apply to food or plants grown for food. If the spray is applied on a food contact surface like an outdoor dining table, wash off with water and dish soap before using for food.
- Keep out of lakes, streams and ponds.
- To prevent electrical shock, do not apply the product into electrical outlets or electrical boxes, or on any bare wires.
- We've tested the product on a variety of surfaces without problems, but it is possible that the plant oils could damage some plastics or finishes or could stain some fabrics, so test treat a small area first. If clean up is needed, use water and dish soap.
- We've tested the product on various types of plants without causing any burning or browning, but test treat a small area first to be certain if you're concerned about plant sensitivity, and be careful not to over-apply.

Store out of reach of children and upright in the original, closed container between 35 and 95 °F. Don't reuse the container. Dispose of in trash or offer for recycling if available.

**Directions for Use**

**Always read label directions and precautions prior to use.**

**Shake well before use and periodically during use.**

This product is designed for outdoor use.

This bottle is designed to hook to a garden hose. The spray top has an off position, a water only position and water plus product position. The nozzle has a fan spray

setting, and a straight stream setting that will shoot up to about 30 ft, depending on water pressure. The fan spray is used for most applications. The straight stream setting is good for shooting from a distance, such as at a nest.

This bottle is designed to empty after about 6 gallons of water has been sprayed. For best results, spray using moderate water pressure, so that it comes out in a nice, gentle fan pattern, at about 2 gallons per minute. Don't use this product in the same area where you've used a Maggie's Farm insect bait. Baits work by the insect eating them. This product is a contact killer and repellent, so you want to be sure not to repel insects from an area where you put down bait. If you want to apply bait in the same area you sprayed, wait and apply bait 2-3 days after spraying.

This product will kill by contact and repel a wide range of flying and crawling insects, plant pests, spiders and ticks. Up to two weeks of mosquito repellency can be expected provided there is no heavy rainfall. Wait a day or two before mowing or watering the treated area for best results.

**Lawn Treatment:** For fleas, ticks, mosquitoes and general insect control, spray in a gentle sweeping motion to cover the area, spending 30 sec to a 1 min per 1000 sq ft (1-2 gals per 1000 sq ft).

**Bushes and Heavy Vegetation:** These are areas where mosquitoes and ticks especially tend to harbor. Spray thoroughly, being sure to get the lower and inner areas, not just the tops. 1-1.5 min (2-3 gallons) per 1000 sq ft of ground area is recommended, using higher amounts for denser vegetation.

**Ornamental Plants:** To kill plant pests, spray at a rate of 30 sec to 1 min (1-2 gals) per 1000 sq ft of ground, making sure to thoroughly wet foliage. Try to get on the underside of leaves as much as possible.

**Building Foundation:** To help keep pests from getting inside, spray the foundation at a rate of 30 sec (1 gal) per 1000 sq ft.

**Stinging Insects:** Be extremely careful when treating nests of stinging insects. Treat from a safe distance using the straight stream setting. For protection, cover as much of your skin as possible with clothing. For best results, treat in the early morning or late evening when the largest number of insects will be in the nest. Thoroughly spray the nest and nest entrances and repeat a day or two later if there is still activity. Individuals who are allergic to insect stings should never treat stinging insects. Have someone else do the treatment or call a professional. This product is recommended for hanging and tree nests. For nests in the ground or nests in walls, Maggie's Farm Spider and Insect Dust is recommended. Read the label directions on that product before using. Certain species such as yellow jackets and hornets are very aggressive. Use extreme caution when treating these insects, or call a professional.
