#### INSTRUCTIONS

fertielome® Weed-Out Plus Lawn Fertilizer controls a wide range of lawn weeds, including Dandelion, Chickweed, Knotweed, Plantain, Henbit, Spurge and other listed weeds commonly found in home lawns. In addition, a 25-0-4 fertilizer provides a supply of plant food. Possible retreatment may be necessary if (a) lawn is heavily overrun by weeds or (b) if adverse low moisture conditions prevail and weeds are in a state of poor growth. A second application may be made in 30 days. Do not use on Dichondra. Do not overapply. Under conditions of adequate moisture, high temperatures and high humidity, over-application may cause minor transitory discoloration on St. Augustinegrass. Do not use this product on "Floratam" St. Augustinegrass.

- 1. Mow lawn to normal height 1 to 2 days before application.
- 2. Water lawn thoroughly at least 1 day before application to sustain moisture until the next watering (see step 4).
- 3. Apply when weeds are young and actively growing, preferably in the morning when dew is on the grass. If grass is not moist at time of application, sprinkle lightly with water to hold the material and prevent dust drift onto nontarget plants.
- 4. Do not wash from weed leaves for 1 to 2 days after application. At this time, a thorough watering should be made.

# HOW MUCH TO APPLY

For Kentucky Bluegrass, Fescues, Perennial Ryegrass, Bermudagrass, Zoysiagrass, St. Augustinegrass, Bahiagrass and Centipedegrass: Apply 3.2 to 4.0 pounds of product per 1,000 square feet of turfgrass. A second or follow-up application may be required for dense infestations of weeds or for adverse seasonal conditions. The second application of 3.2 to 4.0 pounds of product per 1,000 square feet should be used 30 days after the first application.

The maximum broadcast application rate is 4.0 pounds of product per 1,000 sq.ft. per application (0.24 lb 2,4-D ae, 0.42 lb MCPP-p ae and 0.10 lb dicamba ae per acre per application). The maximum number of broadcast applications is limited to 2 per year with a minimum of 30 days between applications. The maximum seasonal rate is 8.0 pounds of product per 1,000 sq.ft. (0.48 lb 2,4-D ae, 0.84 lb MCPP-p ae and 0.20 lb dicamba ae per acre).

A uniform distribution of product on the treated area is essential. Choose a calm day to ensure uniform coverage. Do not exceed the application rate for any area.

#### SPREADER GUIDE

These settings can be used only as a guide, they are not absolute. The speed at which the applicator walks, spreader condition and the texture of the turf will alter the rate of application. If product remains in spreader after application to recommended square foot coverage, spread remainder over same area going at right angles.




