## DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. READ ALL DIRECTIONS COMPLETELY BEFORE USE.

SHAKE WELL BEFORE EACH USE. HOLD CONTAINER UPRIGHT. APPLY IN SHORT BURSTS.

For best results, follow directions for specific use areas. Do not use on animals. Avoid contamination of food and feedstuffs. DO NOT CONTAMINATE FOOD AREAS.

Do not apply this product in a way that will contact adults, children, or pets, either directly or through drift. Remove pets, birds and cover fish aquariums before spraying.

Do not apply when food is present. Remove or cover dishes, utensils, food processing equipment, and food preparation surfaces, or wash them before use. Remove or cover exposed food and drinking water before application.

## OUTDOOR USE:

For use on ornamental plants, shrubs, vines.

All outdoor applications must be limited to spot or crack-and-crevice treatments only, except for the following permitted use: Applications to lawns, turf, and other vegetation. Do not water the treated area to the point of run-off. Do not make applications during rain.

Do not use on edible crops. Take precautions to avoid spraying when wind conditions could create a mist that may blow back to applicator. Do not apply this product in or around bodies of water.

## GARDEN PESTS: NOT FOR USE ON EDIBLE CROPS

Kills the following plant insects: Aphids, Armyworms, Asparagus Beetles, Boxelder Bugs, Cabbage Loopers, Cankerworms, Caterpillars, Chewing Insects, Colorado Potato Beetles, Corn Ear Worms, Cucumber Beetles, Cutworms, Diamondback Moths, Eastern Tent Caterpillars, Flea Beetles, Gypsy Moths (adult and larvae), Inchworms, Japanese Beetles, Lace Bugs, Leaf Miners, Leaf Beetles, Leafhoppers, Leafrollers, Leafhoppers, Mealy bugs, Mexican Bean Beetles, Mites, Oleander Caterpillars, Psyllids, Red Spider Mites, Rose Chafers, Soft Brown Scales, Southern Army Worms, Spider Mites, Spotted Mites, Stink Bugs, Tarnished Plant Bugs, Tomato Fruit Worms, Tomato Pin Worms, Two-spotted Mites, Tent Caterpillars, Thrips, Whiteflies.

WHEN SPRAYING, HOLD CAN 24 – 36 INCHES FROM PLANT. Take precautions when spraying tender or new growth on young plants. First, spray these plants on a few leaves to ensure plant safety before spraying entire plant. For best results, apply in short bursts and spray in the evening or on a cloudy day when air is still.

Lightly mist plants. Use a slow sweeping motion. Avoid excessively wetting plant foliage with spray. Spray plants at the rate of one (1) linear foot per second. For heavy growth, spray both sides of plants. Do not spray when temperature exceeds 90°F.

## STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

**PESTICIDE STORAGE:** Store in a cool, dry area. Always store pesticides in the original container. Store away from food and pet food.

**PESTICIDE DISPOSAL AND CONTAINER HANDLING:** Do Not Puncture or Incinerate! Nonrefillable container. Do not reuse or refill this container. **If empty:** Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency for disposal instructions.
