DIRECTIONS FOR USE

Read entire label. Use only in accordance with label directions and precautions.

For use in and around, but not limited to homes, marinas, barns, patios, pool areas, beach areas and lawn areas.

Cover or remove food. Cover food processing surfaces during treatment or thoroughly clean before use.

Shake product well. Dilute at a rate of 1 part Pyranha 1-10 FT Exempt Concentrate to 40-60 parts water. Add concentrate to water. For example, 1 gallon of the concentrate can be added to 54 gallons of water to provide good control of insects listed. Use less water for more severe infestations. Use more water for preventative applications. **Mix thoroughly after dilution.** Continuous agitation is not required.

Dispense diluted concentrate through an automatic spraying system. Set nozzles to deliver 1.5 ounces of liquid per minute. Locate nozzles to cover a maximum of 1,000 cubic feet of space per nozzle. Set timer to operate in accordance with equipment directions.
