observed at very high doses. These inlcude, a reduced weight gain in males and increased liver weight in females (rats 5,000 ppm); an increase of liver weight in females (hamsters, 2,000 ppm); an increased liver wirhgt in both males and females (dogs 20,000 ppm).

Reproductive and developmental toxicity: Demonstrated no adverse effects on reproduction

in a three generation rat reproduction study.

Teratogenicity: No teratogenic effects were seen in rats at dose levels up to 8-0 mg/kg/day. In rabbits, no adverse effects of biological significance were observed at the low dose (30 mg/kg/day) slight embyrolethal effects were noted at 300 mg/kg/day; severe maternal

toxicity and moderate embyrolethal effects were observed at the highest dose.
